
I have prepared a Fair Market Value estimate of the Polar exploration collection in the Edith Ronne Library located in Bethesda, MD. This appraisal has been done as advice for Estate purposes.

According to our understanding, I performed on-site inspections of the books on September 9 and 14, 2009. A selected 95 books from the collection were subject to appraisal, 31 of which were placed in an estate sale on September 10, 2009. There are 42 books valued at \$100 or higher and seven valued between \$75 and \$100. The values of the remaining 15 and the 31 estate sale titles are reported in aggregate.

The values provided below are based upon the Fair Market Value of equivalent or comparable material, most of which are one-of-kind and unavailable new. The enclosed report reflects my professional opinion based upon my background, education and experience, and upon review of available market data. For the purposes of this appraisal, retail markets, auction records and World Wide Web markets were considered and research was conducted.

After due consideration, I have arrived at an apposite valuation of \$16,980.00 for these items. In reaching this conclusion, I have brought to bear my education and knowledge of books, my over 27 years experience in rare book appraising and specialized training in appraisal practice. As an Accredited Senior Appraiser in the American Society of Appraisers, I have observed their *Code of Ethics* and this report conforms to the *Uniform Standards of Professional Appraisal Practice*, promulgated by the Appraisal Foundation, chartered by the US Congress.

### **Type of Value**

The purpose of this appraisal document is to arrive at an estimate of fair market value for a selection from the books belonging to the estate of Edith Ronne located in Bethesda, MD.

### **Intended Use**

The intended use of this appraisal report is limited to Advice for Estate purposes.

### **Definitions of Value**

Fair Market Value was used to establish apposite value. Fair Market Value is defined as

*Fair Market Value is the price at which property would change hands between a willing buyer and a willing seller, neither being under any compulsion to buy or sell and both having reasonable knowledge of relevant facts. The fair market value of a particular item of property includable in the decedent's gross estate is not to be determined by a forced sale price. Nor is the fair market value of an item of property to be determined by the sale price of the item in a market other than that in which such item is most commonly sold to the public, taking into account location of the item wherever appropriate. Thus in the case of an item of property includable in the decedent's gross estate, which is generally obtained by the public in the retail market, the fair market value of such an item of property is the price at which the item or a comparable item would be sold at retail. [IRS, US Dept. of the Treasury, Part 20-Estate Tax; Section 20.2031 (b).]*

### **Approach to Value**

I have considered the three approaches to value: Cost, Income, and Market Data, and for the purpose of this assignment the Market Data approach is most relevant for

- The researching of appropriate markets for similar books for sales data.
- The confirmation and qualification of sales data that was researched for this appraisal assignment.
- The comparison of comparable or equivalent books.
- The number of comparables that were selected and described in relation to the subject property.
- The value conclusion was reached by analysis of the market patterns that developed.

The Cost approach was not used for the books because new replacements or facsimile (replica) books are not comparable similarly, the Income approach was not applicable because this property is not income producing.



### Market Analysis

Personal property is commonly bought and sold in or at several market levels depending on the quantity, quality and condition of the property. (Soucy & Smith, p 3). The market levels appropriate for this collection of Polar exploration books are both the Major & Minor Auction Liquidation Levels, or price most frequently realized at national or regional auctions; and the Retail Market Level where similar used books are offered for sale. Some of these titles have come on the auction block in the past five years, their appearance is not uncommon. The Used Book Retail Market is the most relevant market for books in this condition and concurrent with the most recent Auction records there are enough comparable titles offered nationally to make estimates of fair market value.

The property being assessed consists of Polar exploration titles in English, Norwegian, Swedish and other languages associated with the Antarctic explorers Finn and Edith Ronne. This category is collected avidly and books autographed by polar explorers are scarce. Many of the books are signed and inscribed to the Ronnes. Travel and exploration books from the 19th and early 20<sup>th</sup> Century are internationally collected. These books are sold more frequently through dealers than in auction sales, although they are well-received when appearing at auction. Books from the travel and exploration genre have held and increased their value for the past 10 years. Many of the most sought after books, especially those by Amundsen, Nansen, Peary, Scott, Shackleton, and Wilkins now command high prices and some titles have become scarce.

Collectors of Polar exploration accounts generally seek books which are both attractive and lively examples of the genre. This collection exemplifies both elements. The predominant focus of the collection is on Polar exploration with auxiliary titles on cartography, history, natural history and biographies of explorers, which can lend greater value to these books as a group, beyond the simple sum of the titles individually.

Individual titles in the collection such as the Ross, Bull, Shackleton, Amundsen and the Peary exploration accounts are avidly collected and examples of the best copies bring high prices in national auction and retail sales. Some of these titles are not in the most collectible condition, however and fell well below their potential value estimates because of their wear. The condition of the items is generally Very Good to near Fine. A few of the titles are in merely Good to Fair condition. My research in antiquarian book markets has verified the caliber of these books.

Research into the current and recent past book values was completed using a variety of wholesale and retail price data as well as internet information. In addition a review of the retail used and rare book markets in the Mid-Atlantic area was made to reach the valuation. Also, a review of auction records and the retail high-end antiquarian used and rare book markets both nationally and internationally was conducted.

### Organization

The books are presented alphabetically by author, the better books – valued at \$100 or more --are presented and described first, then books valued over \$75 are listed. The remaining books and those reviewed as part of the September estate sale are valued in aggregate at the end.

## GLOSSARY

### Book Sizes

Elephant Folio = height about 23"

4to - Quarto, ht. = 9"-12"

12mo - Duodecimo, ht. = 7"-8"

Folio, ht. = 12"-15"

8vo - Octavo, ht. = 8"-9"

16mo - Sextodecimo, ht. = 6"-7"

### Condition

As New - used only when the book is in the same immaculate condition in which it was published. There can be no defects, no missing pages, no library stamps, and so on, and the dust jacket (if it was issued one) must be perfect, without any tears.

Fine - No defects, almost new without being immaculate.

Very Good - Shows some small signs of wear, but no tears.

Good - Average used book.

### Terms

Aeg - All Edges Gilt: top, fore-edge, and foot of the book are colored in gold.

Antiquarian Books - A loose term implying collectible books rather than used books. Refers to old, rare, and out-of-print/used books.

Binding - cover of the book

Blind-stamping - impressed mark, decoration or lettering, not colored or gilded, usually appearing on the binding.

Boards - stiff cardboard binding material

B&W - black and white illustrations, photographs, etc.

Chipped - small pieces missing, or fraying on a dust jacket or edge of a paperback.

Cloth - binding can be linen, buckram or another textile.

Cost Approach to Valuation -

estimates new or depreciated costs necessary to reproduce or replicate a book.

Decorated - dec, decor; Often refers to a binding, as in "dec. cl."

Dj - dust jacket, or dust wrapper, the decorative paper placed over the binding.

End Papers - ep, the sheets of papers pasted onto the inner covers, joining the book to the covers. One side of the sheet is pasted down to the inside cover, the other is left free.

Extremities - edges and corners of spine and covers.

First Edition - 1st ed.; the first appearance of a work in book form, first printing.

Foxing - brown spotting to the paper caused by a chemical reaction, generally found in 19th Century books, particularly in steel engravings.

Frontispiece, frontis. - illustration at the beginning of a book, usually facing the title page.

Gilt edges - aeg = All Edges Gilt; teg = Top Edge Gilt; top page edges have been trimmed smooth and gilt or gold has been applied.

Half cloth - paper covers boards, cloth spine

Half leather - paper or cloth covers, wide leather spine, small leather tips on corners.

Illustrated - Illus; containing pictures.

Income Approach to Valuation -

estimate of the present worth of anticipated future benefits of an income-producing book.

This page not valid if detached from report.

- Inscribed, insc - indicates a book signed by the author, either with an inscription to a specific person or bearing some brief notation along with his signature.
- Limited Edition - Ltd.; publication deliberately restricted to a comparatively small number of copies, usually numbered thus 23/500: the first number being the present volume, the second being the total number in the press run. Often signed by publisher, author or illustrator.
- Marbled - paper decorated with an imitation marble pattern.
- Market Comparison Approach to Valuation - estimates value by comparison with similar books sold in the relevant market.
- Morocco - leather made from goatskin, noted for its durability and beauty.
- Pictorial - picture on the cover
- Plates - whole page illustrations printed separately from the text.
- Offset - transfer of ink from one page to another, as either a printed page or an engraving.
- Quarter Leather - narrow leather spine.
- Rare - implies the book is extremely scarce, perhaps turning up only once every ten years or so.
- rfep - endpaper that is not attached to the inside rear cover.
- Scarce - difficult to find, not necessarily rare.
- Shaken - book whose pages are beginning to come loose from the binding.
- Slipcase - cardboard case covered in paper, cloth or leather which holds a book with only the spine exposed.
- Spine - backbone of the book, covered with a back strip, sometimes also referred to as the spine.
- Teg - top edge gilt
- Three-Quarter Leather - wide leather spine and large leather corner coverings over boards or cloth binding.
- Tipped in - plate, autograph or photo is pasted by its corners to a page bound into the book.
- Tissue Guards - thin, opaque paper covering the plate.
- Tooling - application of gilt pattern onto binding.
- Toned - darkening or discoloration of covers, spine or pages.
- Unopened - leaves are still joined at the folds, not slit apart.
- Vellum - thin sheet of specially prepared skin of calf, lamb, or kid used for writing or printing, or for the cover.
- Waterstained - discoloration and perhaps actual shrinking of the leaves or binding.
- Wraps - outer covers of a paperbound book or pamphlet.
